1. **Aurora Solar LLC** (L-21254A-23-0184-00222) - In the matter of the application of Aurora Solar LLC, a wholly owned subsidiary of Avangrid Renewables LLC (Avangrid) for its application for the approval of two separate Certificated of Environmental Capability for a proposed 230-kilovolt (kV) alternating current generation transmission tie-in line (Gen-Tie Line) and associated substation facilities (collectively, "Project") located in unincorporated Navajo County, Arizona. The proposed project will interconnect directly into the Arizona Public Service Company (APS) owned 230-kC Cholla substation located at the Cholla Power Plant. Two CECs are required to address ownership of separate portions of the Gen-Tie Line. The applicant will own the portion of the Gen-Tie Line from the generation source to the fence/property line of the Cholla Substation ("CEC-1"). APS will own the portion of the Gen-Tie Line inside the fence/property line of the Cholla Substation ("CEC-2"). The Project will deliver electricity from the applicant's planned Obed Meadow Solar Project (Solar Facility), an up to 200-megawatt (MW) nameplate capacity solar photovoltaic power plant that may be paired with an optional 200-MW battery energy storage system.

2. **Winchester Transmission, LLC** (L-21256A-23-0199-00223) - In the matter of the application of Winchester Transmission, LLC in conformance with the requirements of Arizona Revised Statutes, Sections 40-360, et. seq. for a Certificate of Environmental Compatibility Authorizing the Winchester Transmission Project located in Cochise County, Arizona.
